



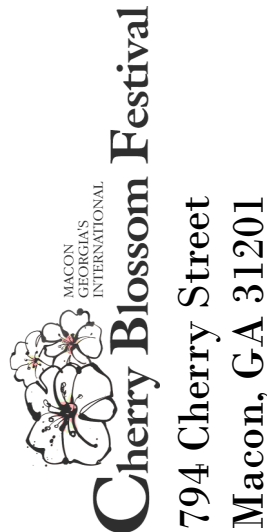
2009 Entertainment Stage Application
